

## **EU Allergens Labelling**

## **Labelling Egg and Milk Products**

This advice represents the information available to Wine Australia at 25 June 2012.

The European Union intends implementing the requirement to label for the presence of milk and egg products from 1 July 2012.

- Wine labelled with a vintage of 2011 and earlier will be exempt from the mandatory labelling requirement.
- Wine labelled with the 2012 vintage will only be exempt if labelled before 30 June 2012.
- 2012 wine labelled after 30 June must comply with the allergen labelling requirement.
- If you have not used milk and egg products in a wine and you are confident that there is no cross contamination then you do not need to indicate the presence of allergens. If you have used milk or egg products and the wine has not tested negative for the presence of residues using a technique with a detection limit of 0.25 mg/l then the presence of residues must be indicated.

The allergen indications may be in one of the following forms:

- Contains milk, Contains milk products, Contains milk casein or Contains milk protein
- Contains egg, Contains egg products, Contains egg protein, Contains egg lysozyme or Contains egg albumin

If multiple allergens are present there is no need to repeat the word "contains". Hence the phrase "Contains sulphites, milk, egg" would suffice if all three allergens were present.

Each EU member state has now stipulated the language in which the allergen indication must be displayed. The EU has published the information listed in Annex 1 with the languages each country will accept.

If wine is to be marketed in all 27 EU countries it may be necessary to label in a minimum of 15 languages. This makes label design very difficult and a pictorial alternative would be very useful.

To that end the Europeans have developed a series of logos (see below) for use in the case where only sulphites are present, or when they are present in conjunction with milk and/or egg residues. The logo cannot be used by itself and must be accompanied by the textual statement about the presence of allergens listed in Annex 1. The logos may be used in colour, gray scale or black and white. No minimum print height has been advised:
